Sealed bids will be received by the **Bishop International Airport Authority**, at the Administration Office until 10:00 a.m. (local time), on the bid date, at which time and place all bids will be publicly opened and read aloud. **ANY BID RECEIVED AFTER THE SPECIFIED TIME WILL NOT BE CONSIDERED.**

The proposed Work includes the following: **Approximately 6,000 square yards of new bituminous asphalt airfield pavement, approximately 48,000 square yards of bituminous asphalt airfield pavement rehabilitation (overlay), construction of new asphalt bituminous paved shoulders, taxiway edge lighting circuit and miscellaneous electrical upgrades, pavement markings, drainage improvements, and restoration.**

Bidder Qualifications

Prime Bidder must be prequalified with MDOT in classification Cb (Hot Mix Asphalt/Bituminous Paving). In addition, this project includes a Designated Item classification of Ea (Grading, Drainage Structures & Aggregate Construction) and a Specialty Item classification of L (Electrical Construction). If the prime bidder is not prequalified in these Designated and Specialty Item classifications, then it must use subcontractors that are prequalified in these classifications. These subcontractors must be designated below, prior to award of the contract to the confirmed low bidder.

There is a Disadvantage Business Enterprise (DBE) participation goal of 5.00% for this project.
